



NY Chapter at the North American Karting Endurance Challenge

On Saturday July 21 I experienced my first gokart race at the Westhampton Gokart Track. The race was organized by Jay de Marken of DINO USA in the North American Karting Endurance Challenge. It was a four hour race that had fifteen teams entered.

As we drove along the winding road leading to the track, I beheld a miniature version of a Formula One track complete with a hair pin, esses and straight-aways. Prior to this event I had ridden in novelty amusement park type gokarts a couple of times but hadn't ever experienced the thrill of competition. My boyfriend, Jeff Tarr, dragged me along, promising it would be fun, so I agreed to go to humor him. I had no idea that the day ahead would be one of the most thrilling

Having done a number of these races in the past, it was clear that Jeff was prepared for the day ahead by bringing along a canopy, folding chairs, a packed cooler,

drivers meeting was called and we got down to serious business. There was no time to spare, the drivers were given a few minutes to suit up in either their own gear or the Dino supplied gear. While I was suiting up, Jeff picked out what he thought would be the two best karts. You see, he brought some other friends with us, some of whom were hot shoes. a popular term for experienced drivers, and others who weren't. He assigned all the hot shoes, including himself, to one kart, and placed me and the rest of us novices in the other.

It was explained that the first session served as both practice



and qualifying for the race. Each driver was given ten minutes of practice time and the fastest lap out of all the drivers was used to determine your starting position. As in Formula One, one fast lap is all we needed during qualifying. Jeff's kart qualified fifth, and my kart qualified seventh thanks to a few laps done by one of our hot shoed companions. Dino puts a twist on starts by inverting the top five qualifiers, so Jeff's kart ended up having the pole position (his third pole position in a row for these events – he later told me he has had much luck with sandbagging during qualifying).

The four hour race requires a minimum of eleven driver changes which means that average stint was twenty minutes. It was a beautiful sunny day, hot but no humidity – a perfect day to be outside. The race started with a rolling two by two start. Jeff took off at the green flag and led the first few laps. One of our ringer hot shoes started our kart to get us off to a good start and

real race conditions. A number of the other teams' drivers tried aggressive moves and ended up spinning out. As the race progressed there were many more spins, which many people, including myself, began to learn how to control and use as a technique to pass by sliding around the competition. Those that didn't catch their spins simply came to a stop and then resumed racing.

I was the third driver for my kart and seeing my friends go before me made me confident that I could handle things. We gave the "IN" sign to our kart signaling the driver to pit for a driver change. The driver came barreling, stopped by our pit stall, in a split second he hopped out, I hopped in and drove off.

I knew that the field was faster than I was, so my goal for the first run was to stay out of peoples' way, learn the track, and explore the cornering limits of the kart. As I got to the hair pin, I lined up and made the turn but forgot to brake. As soon as I realized that I had too much speed I hit the brake and

simultaneously remembered Jeff saying "never hit the brake unless you are going straight or else you will spin" and he was right, I spun out and a few karts passed me. Later I learned that

because these karts only have a single rear brake they are susceptible to spinning while breaking in a turn. When I regained control of the kart, I took a deep breath and a wide grin appeared on my face after realizing that spinning is no big deal and not scary at all. After traversing the course a few times I realized the two most difficult turns for me were the hair pin and the deceptively high speed left turn after the hair pin.

The race for our kart up front was quite suspenseful. With twenty minutes to go that kart pitted to make its final driver change. When we left the pits we were in third place but still on the lead lap. Fourth place was a number of laps behind us so our driver went out thinking he just had to drive smoothly and finish the race and not worry about being passed since any passing kart would not be for a position gain. As it turned out the first and second place karts had not made enough driver changes so they had to stop and make

additional driver changes during the last few minutes of the race. While they stopped our kart took the lead of the race with just seven laps to go. Unfortunately, our driver wasn't aware of this and didn't understand the signals we were giving him on our pit board. With two laps to go both of the karts that had stopped passed us because our driver didn't know better. Had he known, he may have been able to hang on to the lead and win the race.

As for my kart, we came in a respectable 14th out of 15 karts. It didn't matter that we weren't on the podium. We had all learned a lot about kart (and car) control, vehicles dynamics, and, most importantly, how much fun karting can be. Next time I'll be better prepared to go for a podium finish with my new found confidence. Related Links:
